Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015

As per our intimation dated June 18, 2021, to comply with RBI circular no. DoS.CO.ARG/SEC.01/08.91.001/2021-22 dated April 27, 2021, restricting the tenure of statutory auditors of NBFC companies to three years, M/s Walker Chandiok & Co LLP (Grant Thornton) have completed three years as Statutory Auditors of Dhani Loans and Services Limited, (an NBFC and a subsidiary of Dhani Services Ltd) (hereinafter referred to as **DLSL**) and therefore are not allowed to continue as auditors of DLSL any longer in compliance of RBI circular. Accordingly, they have tendered resignation vide letter dated August 13, 2021, from NBFC (letter attached) and will continue to audit the parent company. The NBFC, DLSL has appointed M/s HEM Sandeep & Co, Chartered Accountants (firm registration no. 009907N) as its Statutory Auditors, for a period of three years.

M/s HEM Sandeep & Co., Chartered Accountants have been Statutory Auditors of Punjab National Bank and are the concurrent auditors for Canara Bank, Bank of India, Central Bank, Indian Overseas Bank, Punjab National Bank, IDBI, Punjab & Sind Bank and UCO Bank.
